The Council of the City of Sylvania, Ohio met in regular session on July 15, 2024 at 7:30 p.m. with Mayor Stough in the chair. Roll was called with the following members present: Mark Frye(excused), Marcus Hansen, Doug Haynam, Brian McCann, Patrick Richardson, Mary Westphal, Lyndsey Stough; (6) present; (1) absent.

Roll call: 6 present, 1 absent.

Pledge of Allegiance to the United States of America led by Ms. Stough.

Mayor Stough stated that Council will now consider agenda item 3.



RESOLUTION NO. 9-2024

APPROVING THE PETITION **FOR** SPECIAL ASSESSMENTS FOR SPECIAL ENERGY IMPROVEMENT PROJECTS UNDER OHIO REVISED CODE CHAPTER 1710; APPROVING THE NECESSITY OF ACQUIRING, CONSTRUCTING, AND IMPROVING CERTAIN PUBLIC IMPROVEMENTS IN THE CITY OF SYLVANIA, OHIO IN COOPERATION WITH THE **NORTHWEST** ADVANCED ENERGY IMPROVEMENT DISTRICT: AND **DECLARING AN EMERGENCY.**

WHEREAS, as set forth in Ohio Revised Code Chapter 1710, the Ohio General Assembly has authorized property owners to include their properties within energy special improvement districts ("ESIDs") upon a petition to a municipal corporation or township, which ESIDs are voluntary organizations of property owners who undertake special energy improvement projects for their properties and finance such special energy improvement projects by way of voluntary special assessments; and,

WHEREAS, the Northwest Ohio Advanced Energy Improvement District (the "District") was created under Ohio Revised Code Chapters 1702 and 1710 as an energy special improvement district and established pursuant to Resolution No. 207-11 of the Council of the City of Toledo, Ohio approved on May 18, 2011 (the "Creation Resolution"); and,

WHEREAS, pursuant to the Creation Resolution, the Initial Plan For the Improvements, Services, and Operation of the Toledo Ohio Advanced Energy Improvement District (as amended and supplemented from time to time, "the Program Plan") was adopted as a plan for public improvements and public services under Ohio Revised Code Section 1710.02(F), which plan allows for additional properties within the City of Toledo, Ohio, any other municipal corporation or township in which a portion of the District's territory is located, and any municipal corporation or township which is adjacent to any other municipal corporation or township in which a portion

WHEREAS, this Council duly passed Ordinance No. 91-2024 on August 19, 2024 and determined to proceed with the Project and adopted the estimated Special Assessments (as defined in the Resolution of Necessity) filed with the Clerk of Council and the fiscal officer pursuant to the Resolution of Necessity; and,

WHEREAS, the actual costs of the Project have been ascertained and have been certified to the City in the Petition and the Supplemental Plan for the Project; and,

WHEREAS, the City intends to enter into a Special Assessment Agreement (the "Special Assessment Agreement") to provide for the security for the Project Advance (as defined in the Special Assessment Agreement) and for administration of payments on the Project Advance and related matters with the District.

Section 1. <u>Definitions.</u> Each capitalized term not otherwise defined in this Ordinance or by reference to another document shall have the meaning assigned to it in the Resolution of Necessity.

Section 2. Special Assessments. The list of Special Assessments to be levied and assessed on the Property in an amount sufficient to pay the costs of the Project, which is \$698,982.90, including other related financing costs incurred in connection with the issuance, sale, and servicing of securities, nonprofit corporate obligations, or other obligations issued to pay costs of the Project in anticipation of the receipt of the Special Assessments, capitalized interest on, and financing reserve funds for, such securities, nonprofit corporate obligations, or other obligations so issued, including any credit enhancement fees, trustee fees, and District administrative fees and expenses, which costs were set forth in the Petition and previously reported to this Council and are now on file in the offices of the Clerk of Council and the fiscal officer, is adopted and confirmed. and that the Special Assessments are levied and assessed on the Property. The interest portion of the Special Assessments, which shall accrue at the annual rate of 6.65%, together with amounts used to pay administrative expenses, has been determined by the District and the Toledo-Lucas County Port Authority (the "Authority") to be substantially equivalent to the fair market rate that would have been borne by notes or bonds been issued by the Authority, which Authority is working cooperatively with the District and the City to facilitate the financing of the costs of the Project.

The Special Assessments are assessed against the Property commencing in tax year 2024 for collection in 2025 and shall continue through tax year 2038 for collection in 2039. The semi-annual installments of the Special Assessments shall be collected in each calendar year equal to a maximum semi-annual amount of Special Assessments as shown in Exhibit A, attached hereto and incorporated into this Ordinance.

All Special Assessments shall be certified by the fiscal officer to the County Auditor pursuant to the Petition and Ohio Revised Code Chapter 727.33 to be placed on the tax list and duplicate and collected with and in the same manner as real property taxes are collected and as set forth in the Petition.

The Special Assessments shall be allocated among the parcels constituting the Property as set forth in the Petition and the List of Special Assessments attached hereto and incorporated into this Ordinance as Exhibit A.

- <u>Section 3.</u> <u>Amount of Special Assessments.</u> This Council finds and determines that the Special Assessments are in proportion to the special benefits received by the Property as set forth in the Petition and are not in excess of any applicable statutory limitation.
- Section 4. Waiver of Cash Settlement. Toledo Promenade Shops, LLC (together with its affiliates or controlled entities, the "Owner") has waived its right to pay the Special Assessments in cash, and all Special Assessments and installments of the Special Assessments

shall be certified by the fiscal officer to the County Auditor of Lucas County, Ohio as provided by the Petition and Ohio Revised Code Section 727.33 to be placed by him or her on the tax list and duplicate and collected with and in the same manner as real property taxes are collected and as set forth in the Petition.

- Section 5. Appropriation of Special Assessments. The Special Assessments will be used by the City to pay the cost of the Project in cooperation with the District in any manner, including assigning the Special Assessments actually received by the City to the District or to another party the City deems appropriate, and the Special Assessments are appropriated for such purposes.
- Section 6. Special Assessments File. The fiscal officer shall keep the Special Assessments on file in the Office of the fiscal officer.
- Section 7. Certification to County Auditor. In compliance with Ohio Revised Code Section 319.61, the Clerk of the Council is directed to deliver a certified copy of this Ordinance to the County Auditor of Lucas County, Ohio within 20 days after its passage.
- Section 8. Approving the Special Assessment Agreement. This Council hereby approves the Special Assessment Agreement, a copy of which is on file in the office of the Clerk of Council. The Mayor, or other appropriate officer of the City, or any of them shall sign and deliver, in the name and on behalf of the City, the Special Assessment Agreement, in substantially the form as is now on file with the Clerk of Council. The Special Assessment Agreement is approved, together with any changes or amendments that are not inconsistent with this Ordinance and not substantially adverse to the City and that are approved by the Mayor, or other appropriate officer of the City, or any of them on behalf of the City, all of which shall be conclusively evidenced by the signing of the Special Assessment Agreement or amendments to the Special Assessment Agreement.
- Section 9. Agreements. The City is hereby authorized to enter into such other agreements that are not inconsistent with the Resolution of Necessity and this Ordinance and that are approved by the Mayor, the Law Director, the Auditor, or other appropriate officer of the City, or any of them on behalf of the City, all of which shall be conclusively evidenced by the signing of such agreements or any amendments to such agreements.
- Section 10. Compliance with Open Meetings Requirements. This Council finds and determines that all formal actions of this Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Ohio Revised Code Section 121.22.
- Section 11. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, property and welfare and for the further reason that such energy special improvement project must access funding available to it for a limited time and therefore should be made effective immediately. Provided this Ordinance receives the affirmative vote of five (5) or more members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor;

In 2015 the Service Department was authorized to enter into an engineering contract to evaluate and recalibrate all traffic signals along the Monroe Street corridor with the end goal of developing a coordinated plan for synchronization (Ord. 1-2015).

Since that time numerous signals have been under design/construction including most recently the Monroe/Silica, Monroe/Harroun, and Monroe/Kroger intersections. All spread spectrum radio communications have been removed and new Field Monitoring technology has been implemented corridor wide. Now that those significant improvements have been installed, it is time to revisit the traffic modeling and have timings and synchronization reimplemented.

The Service Department received a proposal from DGL Consulting Engineers in the amount of \$17,300 to provide these services. Their work will include all Monroe Street signals from Erie Street to ProMedica Health and Wellness Center and on Alexis Road from Monroe Street to Elliott Drive. In addition, the intersection of Brint Road and Main Street will be recalibrated and optimized utilizing the traffic data collected as a part of the Brint Road and Harroun Road roundabout traffic study.

The anticipated engineering fees would be funded from the 223-7611-53503 account. We would recommend approval of the proposal from DGL in the amount of \$17,300. Please call if you should have any questions.

Scope of Services

1a. Project Background

The City of Sylvania has been upgrading the Monroe Street corridor through various improvement projects with the US 23 Interchange project set to be started in spring 2025. The interchange design team has completed corridor timing be installed in 2027. The current Monroe Street and W Alexis Road corridor timing is from 2017 and does not account for the numerous signal phasing changes that have occurred over the recent years. Therefore, an interim timing plan to include the recent changes has been requested. As a part of this project the signal timing at Main Street and Brint Road intersection will also be reviewed.

1b. Services Requested / Scope of Work

The following Scope of Work items are based on the industry standards for signal analyses as requested.

- Traffic Data DGL has reviewed the provided traffic information along with ODOT's MS2 website for traffic counts. All of the interchange project intersections were counted in 2022 and are not recommended to be recounted. DGL also has historical counts from previous projects at Monroe/Erie, Monroe/Main, and Monroe/Summit from 2022 or 2024. As a part of the 2023 CMAQ application DGL collected data at Main/Brint, but the traffic data was not sent in for processing. Therefore, no camera will be set up at Main/Brint and only a processing fee will be applied. The following locations are recommended to have turn movement counts (TMC):
 - Monroe Street/Silica Drive
 - o Monroe Street/Harroun Road
 - o Monroe Street/Kroger Drive
 - Monroe Street/ProMedica Drive
 - o Main Street/Brint Road

Because traffic was collected in 2022 on a majority of the project intersections, road segment volume counts at three locations for 14 hours are recommended. These volume counts using Automated Traffic Recorders (ATR) will allow DGL to expand the counted traffic to current volumes and determine the peak hours of the corridors. The following locations are recommended:

- o Monroe Street Between Summit Street and Harroun Road
- o Monroe Street Between US 23 NB ramps and Major Magic's
- W Alexis Road Between Acres Street and Elliot Drive
- Main Street North of Brint
- Field Recon –DGL will conduct an on-site review of the cabinets/controllers on an as needed basis.
 Review of each cabinet is not expected.
- Signal Timing DGL will create three timing plans- AM Peak, PM Peak, and Off-Peak for the corridor. Clearance intervals will be calculated and LPI's will be reviewed where applicable.
- Deliverables DGL will submit local controller data and coordination timing plans to the city and update the DGL plan sets with coordination timing tables.

1c. Schedule

DGL is available to start this work immediately upon your authorization and can complete the study within six (6) weeks of the traffic data collection.

1d. Client/Owner Provided Information

The city will provide the following:

- Current signal timing information
- Proposed signal timing information from the US 23 interchange project

Spring restoration improvements to the Monroe Street corridor are completed and Mosser Construction has completed all remaining punch list items.

The Service Department is requesting a project change order for one item in the spring scope of work. Mosser Construction was required to properly abandon and cap two waterline fittings at the intersection of Richard Becker Place and Monroe Street. Once excavation work was completed it was discovered both fittings required for abandonment were made of lead joints.

Lead joints in waterline systems when encountered are to be removed and replaced with materials that meet with current American Water Work Association (AWWA) and Ohio Environmental Protection Agency (OEPA) standards. As a result, instead of just fitting abandonments and caps Mosser was required to fully replace the fittings and the necessary piping.

As a result, a change order in the amount of \$21,499.63 is necessary to increase the contract amount from \$6,144,736.69 to \$6,166,236.32 for this necessary waterline work. The original contract amount was \$5,906,737.56, so complete through Change Order No. 4 the adjusted contract amount will have increased by 4.39%.

AGREEMENT

THIS AGREEMENT is effective this _____ day of July, 2024, by and between the City of Sylvania ("City") and <u>Tessa Gardella</u> ("Gardella") who desires to become a Police Officer with the City of Sylvania Police Department.

WHEREAS, Gardella was hired on August 5, 2024 as a Police Cadet and pursuant to the terms of the Police Cadet Job Description approved by the Sylvania Civil Service Commission, Tessa Gardella is required to successfully complete Ohio Peace Officer Certification and firearms qualification within one year of date of hire; and,

WHEREAS, upon successful completion of the Ohio Peace Officer Training Academy, Tessa Gardella will be promoted to the position of Police Officer contingent on completion of the 2000 working hour probation period and execution of this Agreement; and,

WHEREAS, Tessa Gardella acknowledges that the City will incur substantial expense in the form of time, effort and money in the screening of applicants seeking employment as police officers and police cadets and in training and paying the wages and instructional fee to Owens Community College for the Ohio Peace Officer Training Academy for Tessa Gardella to obtain the required certification to become a police officer.

WHEREAS, if Tessa Gardella leaves employment with the City prior to December 31, 2027, Tessa Gardella acknowledges that the City will have suffered substantial economic loss due to the payment of expenses and wages to Tessa Gardella and payment of tuition to Owens Community College such that repayment of those expenses should Tessa Gardella resign or be terminated prior to December 31, 2027 is reasonable.

NOW, THEREFORE, in consideration of the terms and conditions herein, the Parties mutually agree as follows:

- 1. The City will provide compensation to Tessa Gardella at the rate of \$20.61 per hour and also paid the sum of Seven Thousand Eight Hundred Fifty Dollars (\$7,850.00) to Owens Community College for Tessa Gardella's Ohio Basic Peace Officer Training Academy, for a total sum to be determined upon completion of the Owens Community College Police Academy.
- 2. Tessa Gardella shall repay the City the costs paid by the City for tuition and wages on Tessa Gardella's behalf associated with the Ohio Basic Peace Officer Training Academy if Tessa Gardella:
 - a. Is terminated or resigns in lieu of termination for violation of any City of Sylvania Police Department Policies and Procedures on or before December 31, 2027;
 - b. Resigns her position as Police Officer with the Sylvania City Police Department on or before December 31, 2027.

- 3. If Tessa Gardella resigns or is terminated by the Sylvania City Police Department as outlined in Items 3(a) and (b) above, repayment of the City's costs shall be as follows:
 - a. The total of all the costs paid by the City for tuition and wages if Tessa Gardella resigns or is terminated on or before December 31, 2025;
 - b. Two-Thirds of the total of all the costs paid by the City for tuition and wages if Tessa Gardella resigns or is terminated between January 1, 2026 and December 31, 2026;
 - c. One-Third of the total of all the costs paid by the City for tuition and wages if Tessa Gardella resigns or is terminated between January 1, 2027 and December 31, 2027.

Repayment shall be made within thirty (30) days of invoice.

- 4. If the City commences litigation against Tessa Gardella for recovery of the costs outlined in Paragraph 4 of this Agreement, Tessa Gardella agrees that she will be liable for any outstanding repayment amount specified in Paragraph 4 above as well as the City's costs to commence the suit, including attorney's fees.
- 5. This Agreement shall be governed by the laws of the State of Ohio and any legal dispute shall have Lucas County as its legal venue.
- 6. This Agreement may be amended only upon written Agreement of the Parties.
- 7. If any provision or any portion hereof contained in this Agreement is held to be invalid or unenforceable, the remainder of this Agreement shall be deemed severable and remain in full force and effect.

The bidding documents for the above referenced project are complete and the Service Department would like to move forward in advertising the project for construction. The scope of work includes modernizing men's and women's restroom facilities in accordance with ADA requirements, creating a multi-purpose facility for gatherings and parties, fully upgrading and modernizing the food preparation and concessions areas, and necessary electrical and HVAC upgrades associated with the improvements.

The estimated construction cost is \$383,698.50. \$200,000 of this improvement will be funded from an Ohio Department of Natural Resources (ODNR) Capital Improvement Community Recreation/Conservation Pass-Through Grant (52.1%) and another \$100,000 in state capital appropriation funds that was originally allocated for the SOMO Flats project was redirected towards this improvement (26.1%). The remaining balance (\$83,698.50) would be cost shared on a 50/50 basis with the Sylvania Area Joint Recreation District (SAJRD) as per Ordinance 34-2024. Funds for this project would be from account 401-7750-52268.

The Service Department will advertise for bids beginning on August 26, 2024 with a bid opening scheduled for September 17, 2024. Construction can start after November 1, 2024 and must be completed by April 30, 2025 prior to the start of summer pool season.

We would request that the Clerk of Council be authorized to advertise for bids.




Parks & Forestry Quarterly Report: April - June, 2024


Man-Hours by Work Type


